From our Executive Presbyter, Dr. Tom Lovell...



Dear Colleagues in Ministry,

Over the better part of the past three years, I have had the honor and privilege of serving as your Executive Presbyter, visiting each of the 26 churches within North Alabama Presbytery. During this time, I have seen, first-hand, the many ways our

congregations are bearing witness to the love and grace of Jesus Christ within their communities and beyond. I have seen the dedication and commitment of pastors who love their churches and who are working tirelessly and selflessly to care for their congregations and lead their churches in ministry in the midst of a difficult ecclesiastical climate. I have seen Ruling Elders who are providing outstanding leadership in congregations, especially in churches which do not have regular pastoral leadership. I have seen a Presbytery which had been struggling for several years with significant conflict as well as the impact of the COVID pandemic, emerge from that struggle with a new sense of care and concern for one another and a renewed desire to be a community of Christ's disciples. While there will certainly be more struggles as we seek to respond to our call to serve Christ in the weeks, months, and years ahead, I am confident that God will provide all that North Alabama Presbytery will need not only to confront those struggles, but to push through them in ways that give God glory and praise.

It has truly been a joy to serve as the Executive Presbyter of North Alabama Presbytery for the past three years, but the time has come for me to relinquish that position. One of the reasons that Krista and I decided to retire from full-time ministry in 2021 was to spend more time with our grandchildren, and our part-time work with the Presbytery has allowed us to do that. However, three of those grandchildren will soon be moving to Virginia as our daughter has accepted a call to serve as Pastor of The Presbyterian Church of Fredericksburg. With our youngest son and his family living in the Baltimore area, Krista and I have decided to begin the process of selling our home in Huntsville and moving northward that we might live in close proximity to them. As I shared with the Executive Commission, I will gladly continue to serve the Presbytery as its Executive Presbyter until we move or until another Executive Presbyter is in place.

Both Krista and I have greatly enjoyed working with getting to know and the saints of North Alabama Presbytery and have appreciated the love and support you have extended to us. We have every confidence that God will provide new leadership for the Presbytery that it may continue to bear a bold witness to the love and grace of Jesus Christ.







Highlights from the **PWP Fall Gathering:**
